

# **Client Agreement**

This document explains how we [me, the psychotherapist and you, the client(s)] work together.

#### **Sessions length and fees**

A standard Contemporary Psychotherapy (CP) session lasts for 50 minutes. Sessions are usually on a weekly basis at a time mutually agreed at the start of the therapy. My fee is £55 per one—to-one session and £100 per couple's session. If requested, a Pesso Boyden System Psychomotor (PBSP) 'structure' which lasts typically between 60 and 75 minutes the fee is £70.

For group PBSP work the costs may vary and will usually be set out in the information sheet for each group. Reduced fees may be available in the case of financial hardship, subject to availability.

#### **Cancellation Policy**

The online session or room reservation will be held for you each week and the fee will be payable to keep your session whether you attend or not. Sessions can be rearranged and I ask for a few day's notice to facilitate this. Only in exceptional circumstances, at the discretion of the therapist will the fee be waived. Holiday periods should be agreed in advance with as much notice as possible. In the event that I have to miss a session you will not be charged for that session.

## **Code of Ethics**

I adhere to the code of ethics for Professional Counsellors required by UKCP (United Kingdom Council for Psychotherapy), and COSRT (College of Sex and Relationship Therapy) The codes of ethics can be found in more detail on the website of each organisation.

#### Insurance

I carry professional liability insurance and have been enhanced DBS (criminal records) checked.

## Confidentiality

Your personal details, the content of our sessions and my case notes will be kept confidential.

Exceptionally, where there is a risk of harm or when required by law, I may need to make limited disclosure to a third party. Wherever possible, and if it is considered appropriate, you will be informed of this. The Coronavirus contact tracing process has been established in the public interest to control the Covid 19 infection rate. If I, or anyone I come into contact with, develops Covid 19 symptoms, I may be required to share details of your name and contact details with the Contact Tracers. No details of the nature of our work together will be shared. Please be advised that I will not provide a court report or present as a witness on your behalf at any court case relating to any therapeutic alliance. Counsellors' notes are considered to be an aide-mémoire of reported events and as such are not admissible by the court.

#### My continued professional development

To ensure good practice, my work is regularly monitored in clinical supervision. This is a professional requirement of my accrediting organisations. You will never be identified to my supervisor(s) by full name, and any information that my supervisor(s) receive is also treated as confidential and subject to the same ethical criteria as our psychotherapy.

#### Recording

Some of our sessions may be filmed or recorded for me to have my performance evaluated by my supervisors. This will only ever take place with your full permission and I will ask you to sign a consent form for this at the time. You have the right to withdraw your permission at any time and for any reason.





# **Evaluation**

I use standard evaluation systems, which have been developed to help providers of psychological therapies deliver and develop the best possible services to clients. As part of these systems, you may be asked to complete a brief questionnaire. These questionnaires assist me in understanding your problems, and ultimately, the degree to which I have helped you with those problems.

#### **Contact with me**

Text is the best way to contact me as I cannot answer my phone if I am with a client.

## Protocol for face-to-face contact outside sessions

Should we meet outside your session please be aware that I will not greet you. This is to protect your privacy and maintain confidentiality. This is especially important if you are with other people. If you acknowledge me openly, then I will respond in an appropriate professional manner. Should we find ourselves in a situation where we are part of the same group either social of professional, serious consideration will be given to the complications of this dual role relationship. Where appropriate, and possible, I will end my therapy work with you and help you find an alternative psychotherapist.

## Facebook, Twitter, Linked in and all social media

Please do not invite me to join you on any social media. I am not permitted to do so under my strict Codes of Ethics, and refusal may cause offence where none is intended.

## **Covid 19 Disclaimer**

You must assess your own personal risk and comfort when deciding to attend in-person sessions. Although I am taking every possible precaution to mitigate the risk of Covid- 19 contamination or infection, this risk cannot be eliminated. Therefore, I cannot be held responsible or liable should you contract Covid-19 whilst attending in-person sessions. By signing this contract, you are acknowledging that you are in agreement to proceed on this basis.

#### **Exclusions**

It is expected that you do not drink alcohol or take non-prescription drugs before a therapy session.

My psychotherapy is for individuals or couples only; no other person will be permitted in the counselling room at any time or for any reason.

I reserve the right to terminate therapy if you are not abiding by the agreement, or are perceived to be a threat to my well being. Abusive behaviour is unacceptable and will not be tolerated.
